4. PLEASE NOTE: The following methods of payment are available:

- If full payment up front is received before the 7th January for the full amount an 8% discount will be offered; or 4% discount (if paid before 31st Jan).
- If fees are paid quarterly in advance a discount of 2.5% on the term's fees will be offered.
- Fees, other than Grade 12, are payable over 12 months via a monthly **Debit Order (Form Attached)**, payable in advance, and by no later than the 7th of each month. (see also point 10 below)

5. Additional Costs:

- Any outings, excursions or camps. (Parents will be notified of the costs prior to each event.)
- Photocopy notes as per stationery lists.
- Textbooks, workbooks, diaries & materials for art as per stationery list per grade.
- All IEB levies (Grade 12 – NSC Exams, Grade 11,10,9,6 & 3 – Benchmark Tests)
- Olympiad Fees.
- Group Personal Accident Insurance
- Capital Development Levy

6. Work Materials: If for any reason you may decide to withdraw your child from the Schools at short notice, you will be liable for all photocopies and stationery issued.

7. **Transfer or Termination of Agreement:** All transfers and withdrawal of pupils from the Schools shall be subject to a full **TERM'S** notice period. Such notice must be given prior to the start of the next term. Failure to comply with the above clause will automatically make parents liable for three months' school fees. This is due to the fact that teacher appointments, student enrolments and general planning are all costly arrangements for which sudden withdrawal of pupils is disruptive.

8. Government: The school is governed by its Board of Directors who is accountable to the leadership of Southcity Church International.

9. I/We have read & understood the Southcity Credit Policy and agree that Fees will be paid in advance by the 7th of each month.

10. It is a further condition of this fee agreement that all fees payable as set out in this agreement above, shall be paid by way of debit order. I/We agree to complete the detailed debit order instruction on date of signature hereof.

Please note that the above points are subject to change from year to year due to unforeseen adjustments.

I / We understand that should the required fees not be paid by the due date, the Administrator may be forced to withhold or terminate the registration of my child/children at the school. We accept that I/we are jointly and severally liable for the outstanding school fees.
